**TERMINATION AND RELEASE OF  
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Trademark Release”) is made as of February 27, 2018, by **DEUTSCHE BANK AG NEW YORK BRANCH**, a German foreign banking corporation (the “Administrative Agent”) in favor of **ARCHIVE SYSTEMS, INC.**, a Delaware corporation with an address at 39 Plymouth Street, Fairfield, New Jersey 07004 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain first lien trademark security agreement dated December 16, 2015 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on December 18, 2015 at the United States Patent and Trademark Office at Reel 5692, Frame 0757.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest. The Administrative Agent further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.




