## RELEASE OF TRADEMARK SECURITY INTEREST

This Release Of Trademark Security Interest ("**Release**") is made and effective as of February 26, 2018, 2018 and granted by Clutterbuck Capital Management, LLC, a Delaware limited liability company (collectively and together with their successors and assigns, the "**Secured Parties**"), in favor of Straight Path Communications Inc., a Delaware corporation ("**SPCI**"), Dipchip Corp., a New York corporation ("**Dipchip**"), Straight Path IP Group, Inc., a Delaware corporation ("**SPIG**"), Straight Path Spectrum, Inc., a Delaware corporation ("**SPS**"), Straight Path Advanced Communication Services, LLC, a Delaware limited liability company ("**SPACS**"), Straight Path Spectrum, LLC, a Delaware limited liability company ("**SPS LLC**"), Straight Path Ventures, LLC, a Delaware limited liability company ("**SPV**"), (SPCI, Dipchip, SPIG, SPS, SPACS, SPS LLC, SPV, together with their permitted successors and assigns, the "**Company**").

WHEREAS, pursuant to that certain Security Agreement dated as of February 6, 2017 (as amended, restated modified or otherwise supplemented from time to time (the "**Security Agreement**") among the Company, Secured Parties, and other parties thereto, the Company executed and delivered to Secured Parties that certain Intellectual Property Security Agreement by and between the Company and the Secured Parties dated as of February 6, 2017 (the "**IP Security Agreement**" and, together with the Security Agreement, the "**Security Agreements**");

WHEREAS, pursuant to the Security Agreements, the Company pledged and granted to the Secured Parties a security interest in and to all of the right, title and interest of Company in, to and under the Trademark Collateral (as defined below);

WHEREAS, the IP Security Agreement was recorded with the United States Trademark and Trademark Office at Reel/Frame No. 5989/0563 on February 15, 2017; and

WHEREAS, the Company has requested that the Secured Parties enter into this Release in order to effectuate, evidence and record the release and reassignment to the Company of any and all right, title and interest the Secured Parties may have in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Parties hereby state as follows:

1. Release of Security Interest. The Secured Parties, their successors, legal representatives and assigns, hereby terminate the IP Security Agreement and terminate, release and discharge any and all security interests that the Secured Parties have pursuant to the Security Agreements in any and all right, title and interest of the Company, and reassign to the Company any and all right, title and interest the Secured Parties may have, in, to and under the following (collectively, the "**Trademark Collateral**"):

(a) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule A hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof ("**Trademarks**"); and


(b) all rights of any kind whatsoever of Company accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world.

2. Further Assurances. The Secured Parties agree to take all further actions, and provide to the Company and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Company and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
