**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

WHEREAS, **Singlehop LLC**, a Delaware limited liability company ("SingleHop") and **Hosting Intellect, LLC**, a Delaware limited liability company ("Hosting" and together with Singlehop, individually and collectively, jointly and severally, "Grantor"), entered into that certain Loan and Security Agreement on or about May 5, 2014 with **Silicon Valley Bank** ("Bank").

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, Bank hereby releases, terminates and discharges any and all of its interest in the intellectual property of Grantor, including without limitation the Trademarks and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assign, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens. Bank further hereby waives and relinquishes all its rights, powers, privileges, and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants obligations, liabilities and warranties in association with the Security Interest.
