## RELEASE OF SECURITY INTEREST

**THIS RELEASE OF SECURITY INTEREST** (this "Release") is made as of March 1<sup>st</sup>, 2018 ("Effective Date") by Fifth Third Bank ("Lender") in favor of Connecticut Electric, Inc. a Delaware corporation (f/k/a Connecticut Electric Merger Co. and successor-by-merger to Connecticut Electric Inc.) ("Grantor"). All terms not herein defined shall have the meanings set forth in the Security Agreement referenced below.

**WHEREAS**, Grantor, CESM Holdings LLC, a Delaware limited liability company, Tacoma Electric Supply, LLC, a Delaware limited liability company (f/k/a Tacoma Electric Supply, Inc.) (collectively, "Borrowers") and Lender are parties to that certain Loan Agreement dated as of December 18, 2013 (as may be amended, restated, supplemented or otherwise modified from time to time, (the "Loan Agreement"));

**WHEREAS**, pursuant to the Loan Agreement, the Grantor was required to execute and deliver a Patent, Trademark and License Security Agreement dated as of December 18, 2013 (the "Security Agreement") in favor of Lender for purposes of filing with the United States Patent and Trademark Office ("USPTO");

**WHEREAS**, pursuant to the Security Agreement, Grantor granted to Lender a security interest in all of the Grantor's right, title and interest, including goodwill in the trademarks, in, to and under the United States patents, trademarks (including all registrations and applications therefore) and domain names listed on the attached Schedule A (the "IP Collateral");

**WHEREAS**, the Security Agreement was recorded in the USPTO on March 4, 2014, at Reel/Frame 5230/0006; and

**WHEREAS**, Lender wishes to release its security interest in the IP Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, releases and discharges any security interest in and lien upon the IP Collateral, and assigns, transfers, and conveys to the Grantor any and all right, title or interest in, or to, the IP Collateral that Lender may hold.

Lender agrees, at the Grantor's expense, to take all further actions, and provide to the Grantors and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
