## RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (the “**Release**”) is made and effective as of February 28, 2018 and granted by WEBSTER BANK, NATIONAL ASSOCIATION, a national banking association (the “**Lender**”), in favor of ELIZABETH ARDEN SPAS, INC., an Arizona corporation (“**Debtor**”).

**WHEREAS**, pursuant to the terms and conditions of that certain Loan and Security Agreement (the “**Security Agreement**”) dated as of March 4, 2014 (as amended, restated, supplemented or otherwise modified from time to time) by and among, among others, the Debtor and Lender, the Debtor and Lender entered into that certain Trademark Security Agreement dated as of March 4, 2014 (the “**Original Trademark Security Agreement**”) and that certain Amendment No. 1 to Trademark Security Agreement dated as of January 29, 2016 (the “**Amendment**”) and collectively with the Original Trademark Security Agreement, the “**Trademark Security Agreements**”);

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement and the Trademark Security Agreements, Debtor granted Lender a continuing security interest in and to, and lien on, all of Debtor’s right, title, and interest in, to and under certain Collateral (as defined in the Original Trademark Security Agreement), including, without limitation, the trademarks set forth on Schedule A attached hereto (the “**Trademarks**”); and

**WHEREAS**, the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 7, 2014, at Reel 5232, Frame 0902 and the Amendment was recorded with the United States Patent and Trademark Office on January 29, 2016, at Reel 5719, Frame 0523.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby states as follows:


1. Release of Security Interest. Lender hereby terminates the Trademark Security Agreements and terminates, releases and discharges any and all security interests that it has pursuant to the Trademark Security Agreements in any and all right, title and interest of the Debtor, and reassigns to the Debtor any and all right, title and interest that it may have, in, or to the Trademarks.
2. Further Assurances. Lender agrees, at the Debtor’s expense, to take all further actions, and provide to the Debtor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Debtor’s and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and

construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
