NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest is given this 1st day of March, 2018 by Compass Bank, as Administrative Agent (the "Administrative Agent") for the Secured Parties (as defined in the Credit Agreement referred to below), to Professional Placement Resources, LLC, a Florida limited liability company (the "Grantor"). All terms used herein which are not otherwise defined herein, shall have the respective meanings assigned thereto in the Credit Agreement or Security Agreement (each as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement dated as of February 1, 2017 (which amended and restated that certain Credit Agreement, dated as of October 25, 2016, as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among PPR Holding Corporation, a Delaware corporation ("Holdings"), Grantor, as Borrower, the other Loan Parties (as defined in the Credit Agreement) from time to time party thereto, the lenders from time to time party thereto (the "Lenders") and the Administrative Agent, the Lenders have severally agreed to make extensions of credit to Grantor upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement Grantor executed and delivered that certain Guarantee and Collateral Agreement, dated as of October 25, 2016, in favor of the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement");

WHEREAS, Grantor granted to the Administrative Agent a security interest in its Trademark Collateral, including, without limitation, those Trademarks identified on Schedule A attached hereto, pursuant to a certain Intellectual Property Security Agreement, dated as of October 25, 2016 (the "Security Agreement") and recorded on November 1, 2016 in Reel 5911, Frame 0971;


WHEREAS, the extensions of credit and the obligations secured by said security interest have been paid and satisfied in full and irrevocably discharged, terminated and released; and

NOW THEREFORE, for and in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without recourse and without any representation or warranty, hereby terminates the Security Agreement and releases, relinquishes and terminates any and all liens, security interests or other interests in or rights it may have acquired through the Security Agreement in the Trademark Collateral and any other IP Collateral, and the recording officer in the U.S. Patent and Trademark Office is hereby authorized to cancel the Security Agreement of record.


