RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “**Release**”) is made effective February 28, 2018, by ESCALATE CAPITAL PARTNERS SBIC III, LP, a Delaware limited partnership (together with its successors and assigns, “**Lender**”).

WHEREAS, reference is made to that certain Intellectual Property Security Agreement dated May 19, 2017 (the “**IP Security Agreement**”), by and between Maestro Health, Inc., a Delaware corporation (“**Parent**”), Integra Employer Health, LLC, a Delaware limited liability company (“**IEH**”), Integrahealth Management, LLC, a Delaware limited liability company (“**IM**”), Colton Groome Benefit Advisors LLC, a Delaware limited liability company (“**CGBA**”), Group Associates, Inc., a Michigan corporation (“**GA**”), and Workable Solutions, LLC, a Florida limited liability company (“**WS**”, together with Parent, IEH, IM, CGBA, and GA, collectively, the “**Borrowers**”), and Lender, and recorded with the US Patent and Trademark Office on December 22, 2017 at Reel and Frame Number 6235/0630; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to them in the IP Security Agreement; and

WHEREAS, under the IP Security Agreement, Borrowers granted Lender a continuing security interest in all of the right, title and interest of Borrowers in and to the intellectual property collateral identified therein (the “**Intellectual Property Collateral**”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the Intellectual Property Collateral, including, without limitation, the intellectual property described in Schedules A, B, and C attached hereto.


