**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This RELEASE, dated as of March 5, 2018 (“Release”), is made by SJC DLF III-C, LLC, in its capacity as agent for each member of the Secured Parties (in such capacity, together with its successors and assigns in such capacity, “Agent”), in favor of A. H. HARRIS & SONS, INCORPORATED (“Debtor”) as follows:

**W I T N E S S E T H:**

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 31, 2016 (the “Security Agreement”; capitalized terms used and not defined herein having the meanings assigned to such terms therein or in agreements referenced therein), and recorded with the United States Patent and Trademark Office on April 1, 2016 at Reel/Frame 5763/0473, the Debtor granted the Agent a Security Interest in certain collateral pledged by the Debtor described therein, including, without limitation, the United States trademarks set forth on Schedule I attached hereto (collectively, the “Trademark Collateral”);

WHEREAS, the Debtor has paid all of its outstanding Obligations; and

WHEREAS, the Debtor has requested that the Agent release its Security Interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, at the Debtor’s sole cost and expense, hereby terminates, cancels and releases the Security Interest in the Trademark Collateral, and any and all right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide Debtor with any information and additional authorization and documentation necessary to effect the release of the Agent’s Security Interest in the Trademark Collateral (at Debtor’s sole cost and expense).
