**CONFIRMATION OF ASSIGNMENT OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

This CONFIRMATION OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARK RIGHTS (the "Confirmation Agreement") dated as of December 11, 2017, is made by MORGAN STANLEY SENIOR FUNDING, INC., as assignor (the "Assignor") and GOLDMAN SACHS LENDING PARTNERS LLC, as assignee (the "Assignee"). Capitalized terms used but not defined herein shall have the meanings given to them in the First Lien Credit Agreement or Security Agreement (each as defined below) unless otherwise specified herein.

WITNESSETH:

WHEREAS, Husky Injection Molding Systems Ltd. ~~(a Delaware or Ontario~~ corporation (the "Grantor"), the Lenders, Assignor and the other parties thereto entered into that certain Credit and Guaranty Agreement, dated as of June 30, 2011, as amended and restated on June 30, 2014 (the "First Lien Credit Agreement");

WHEREAS, pursuant to that certain Security and Pledge Agreement dated June 30, 2011, (as amended and restated on June 30, 2014, the "Security Agreement"), (i) Grantor has granted a security interest (the "Security Interest") to Assignor, as Collateral Agent for Lenders thereunder, in certain Intellectual Property, including the Trademarks set forth on Schedule A (the "Trademark Collateral"); and (ii) Assignor and Grantor executed that certain Intellectual Property Security Agreement dated as of June 30, 2011 (the "IP Security Agreement") to record such Security Interest at the U.S. Patent and Trademark Office, and such Security Interest was recorded at the USPTO on July 12, 2011 at Reel 4580 and Frame 0486;

WHEREAS, pursuant to that certain (i) Resignation, Waiver, Consent and Appointment Agreement, dated as of June 30, 2014, among Grantor, Assignee, Assignor and other parties thereto, and (ii) Partial Payoff Letter, dated of June 30, 2014 (collectively, the "2014 Agreements"), Assignor assigned to Assignee, effective of June 30, 2014, each of the Liens and security interests granted to Assignor under the 2011 Loan Documents and Assignee assumed all such Liens, for its benefit and for the ratable benefit of all other Secured Parties under the Loan Documents; and

WHEREAS, Assignor and Assignee wish to confirm and record that the 2014 Agreements assigned Assignor's Liens and security interests in the Trademark Collateral to Assignee;

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the parties hereto state as follows:

1. Assignment. Assignor and Assignee hereby confirm that, pursuant to the 2014 Agreements, as of June 30, 2014, Assignor assigned all of Assignor's Security Interest in the Trademark Collateral to Assignee. The Security Agreement (and all rights and remedies of Collateral Agent and Secured Parties thereunder) shall remain in full force and effect in accordance with its terms and is incorporated fully herein by reference. In the event of any conflict between the terms of this Confirmation Agreement and the Security Agreement, the Security Agreement shall govern.



Assignor take all further actions and execute and deliver all further documents reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Confirmation Agreement. The Assignor hereby authorizes and requests that the Commissioner for Trademarks of the USPTO record this Confirmation Agreement.

3. Counterparts. This Assignment and Assumption may be executed by the parties to this Agreement in any number of separate counterparts (including by facsimile or PDF signatures), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.


