TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement"), effective as of November 29, 2016 (the "Effective Date"), is by and between Higher Road, LLC, a Nevada limited liability company ("Assignor") and Redmond LLC, a Minnesota limited liability company ("Assignee").

RECITALS

AGREEMENT


In consideration of the above recitals and the promises set forth in this Agreement, the parties agree as follows:

The provisions of this Agreement inure to the benefit of Assignee, its successors, assigns and other legal representatives, and are binding upon Assignor, its successors, assigns and other legal representatives.

Seller agrees that it will, at any time and from time to time after delivery hereof, upon the request of Buyer, and at the expense of Seller, do, execute, acknowledge or deliver, or will cause to be done, executed, acknowledged and delivered, all such further acts as may be reasonably requested to carry out the provisions hereof and give effect to the transactions contemplated by this Agreement.
