

#### INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

NOW, THEREFORE, in consideration for the execution of the APA and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor sells, assigns and transfers to Assignee, and Assignee accepts the sale, assignment and transfer, of Assignor's entire right, title and interest in and to: (a) the Trademarks, the goodwill of the business associated with the Trademarks and any common law rights related to the Trademarks; (b) any other Intellectual Property owned by Assignor as it relates to the Assets and all rights (common law or otherwise) of any kind whatsoever of Seller accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; and (c) all rights to seek and collect damages and other relief for past and future infringements and all proceeds thereof, all as existing on the date hereof, and all of the foregoing to be held and enjoyed by Assignee as fully and as entirely as the same would have been held and enjoyed by Assignor had this assignment not been made. The Assignor agrees that the Assignee has the right to proceed alone with the recording of this Assignment.

Assignor hereby authorizes the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, as may be reasonably necessary to effect, evidence or perfect the assignment of the Trademarks and other Intellectual Property to Assignee, or any assignee or successor thereto.

This Assignment is subject to the terms, conditions, representations and covenants as set forth in the APA, all of which to the extent applicable are incorporated herein by reference. Nothing in this Assignment, express or implied, is intended or shall be construed to expand or defeat, impair or limit in any way the rights, obligations, claims or remedies of the parties as set forth in the APA.
