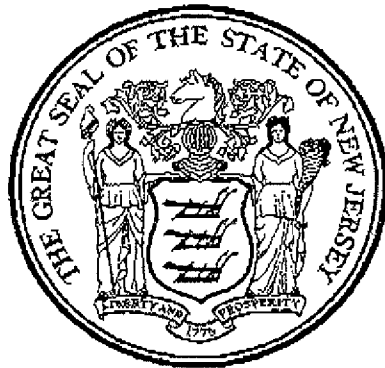

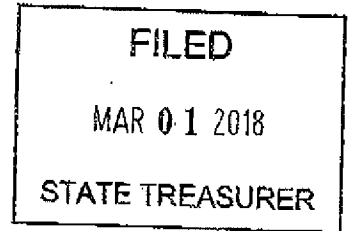

1. The name of the Corporation is **POR-15, INC.**
2. The Corporation's Certificate of Incorporation was filed by the State of New Jersey on October 10, 1986.
3. The following amendments to the Corporation's Certificate of Incorporation were approved by the Joint Unanimous Written Consent of the Corporation's Members of the Board of Directors and the Sole Voting Stockholder as of the 28th day of February, 2018.


