ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (this "Assignment") is made as of January 26, 2018 (the "Effective Date"), by and between Color Image Apparel, Inc., a California corporation (the "Assignor"), and ALO, LLC, a California limited liability company (the "Assignee").

Recitals

Assignor is the owner of the trademarks used in the United States of America (the "USA Trademarks") listed on Schedule I, and is the owner of the trademarks used outside of the United States of America (the "Foreign Trademarks") listed on Schedule II both of which are attached hereto and incorporated herein by reference. The USA Trademarks and Foreign Trademarks are collectively referred to as the "Trademarks."

Assignee wishes to acquire all the right, title and interest in and to the Trademarks, and any pending applications and registrations thereof, together with the goodwill pertaining thereto.

Assignee is the successor to the portion of the business to which the Trademarks pertain, and that business is ongoing and existing, pursuant to Section 10 of the Trademark Act, 15 U.S.C. § 1060; 37 C.F.R. § 3.16.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor assigns the Trademarks and any registrations thereof, together with the goodwill pertaining thereto, to Assignee as follows:

1. GRANT OF RIGHTS:

Assignor irrevocably grants, transfers, assigns and delivers to Assignee, all right, title and interest of every kind and character throughout the world that it has in and to the Trademarks, and the goodwill of the business pertaining thereto, including the right to and all claims for past damages, it being acknowledged and understood that it is the intention of this assignment to confer upon Assignee Assignor's full and complete title to, interest in, and ownership of, the Trademarks.

2. REPRESENTATIONS AND WARRANTIES:

Assignor represents and warrants as of the Effective Date:

2.1. Assignor is the owner of the Trademarks free and clear of any lien, encumbrance, claim or challenge other than the grant of a security interest in the Trademarks by Assignor to Comerica Bank, a Texas banking association, in its capacity as Agent and in its capacity as a Lender under the Revolving Credit and Term Loan Agreement dated May 14, 2014 (as amended

from time to time, the “Credit Agreement”) entered into by Assignor, Agent, the Lender and the other Lenders from time to time who are party thereto, and, to Assignor’s knowledge, the Trademark registrations are duly perfected, fully paid to date, and in good standing, and all trademark applications are pending without opposition or objection by any third party.

2.2. Except as otherwise set forth in 2.1 above, Assignor has not previously assigned to any other person its ownership, right, or title, in whole or in part, to any of the Trademarks. This Assignment is subject to, and the assigned Trademarks will continue to be subject to, the security interest granted to the Agent on behalf of the Lenders as provided under the Credit Agreement.

2.3. If required under the Credit Agreement, Assignor will obtain from the Agent, on behalf of the Lenders, the consent of the Agent and the Lenders to the assignment and transfer of the Trademarks hereunder, provided that Assignee will cooperate with Assignor in executing, acknowledging and delivering such security agreements, assignments, conveyances and other assurances, documents and instruments of collateral assignment to the Agent, on behalf of the Lenders, as Assignor may reasonably request from time to time for the purpose of obtaining such consent of Agent, and provided further that Assignee shall take any and all such other actions consistent with the terms of this Assignment and the continuation of the security interest grant to the Agent on behalf of the Lenders in the Trademarks as may be required under the Credit Agreement, the Security Agreement (as defined in the Credit Agreement), and any other agreements, documents or instruments associated with or related to the Credit Agreement, Security Agreement, and any such other agreements, documents or instruments.

3. RIGHTS AND OBLIGATIONS:

Assignor agrees to execute and deliver or cause to be executed and delivered to Assignee or any purchaser of the Trademarks from Assignee any and all documents and instruments, in form and substance reasonably satisfactory to Assignee and its counsel, necessary to effect and complete the assignment, transfer, grant or sale to Assignee of all rights or property acquired or intended by Assignor and Assignee to be acquired by Assignee under this Assignment, and shall pay any fees or expense found due and owing prior to the date of this Assignment.

4. ASSIGNMENT:

The obligations, representations and warranties of Assignor herein may be transferred by Assignee to any purchaser of the Trademarks from Assignee and such purchaser may enforce the representations and warranties as though made to it. This Assignment shall bind and inure to the benefit of the Assignor and the Assignee and their respective successors and assigns.

5. AUTHORIZATION.

Assignor authorizes the Commissioner of Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record the Assignee as the assignee and owner of any and all of Assignor’s rights in the Trademarks and the registration thereof including any renewals, extensions or maintenance filings thereof or relating thereto.

6. COUNTERPARTS.


This Assignment may be executed in one or more counterparts, or by the parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but both of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment transmitted by facsimile or via the Internet as a PDF or JPEG electronic format file, shall be effective as delivery of a manually executed counterpart of this Assignment for all purposes.
