## **RELEASE OF TRADEMARK AND LICENSE SECURITY AGREEMENT**

This Release of Trademark and License Security Agreement, effective as of December 29, 2017, is made by BMO Harris Bank N.A., formerly known as Harris N.A., a national banking association ("Agent"), as agent for Lenders, in favor of Danielson Outdoors Company, Inc., a Delaware corporation ("Grantor"). Capitalized terms used but not otherwise defined in this Release of Trademark and License Security Agreement shall have the meanings assigned to them in the Trademark and License Security Agreement (as defined below).

WHEREAS, pursuant to the Loan Agreement, Agent and Grantor entered into that certain Trademark and License Security Agreement dated as of June 19, 2009 (the "Trademark and License Security Agreement"), and


WHEREAS, the Trademark and License Security Agreement was recorded with the United States Patent and Trademark Office at Reel 004012, Frames 0458-0470; and

WHEREAS, under the terms of the Trademark and License Security Agreement, Grantor granted to Agent, for Agent's benefit and the ratable benefit of Lenders, a security interest in the Trademarks (including without limitation those trademarks appearing on Schedule A attached hereto), the goodwill of Grantor's business connected with and symbolized by the Trademarks, and the Licenses (collectively, the "Trademark Collateral").


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of itself and Lenders, does hereby (i) cancel and terminate the Trademark and License Security Agreement, (ii) declare the same null and void, of no further force and effect, and (iii) cancel, terminate, release and discharge its entire interest in all of the Trademark Collateral.
