## ASSIGNMENT

This Assignment (hereinafter “Agreement”) is made and entered into effective as of September 26, 2017, by and between Wiz Khalifa Trademark, LLC, a limited liability company formed under the laws of the state of California, with an address of 10990 Wilshire Blvd., 8<sup>th</sup> Fl. c/o WG&S, Los Angeles, CA 90024 (hereinafter, the “Assignor”), on the one hand, and Taylor Gang Trademark, LLC, a limited liability company formed under the laws of the state of Delaware, with an address of 10990 Wilshire Blvd., 8<sup>th</sup> Fl. c/o WG&S, Los Angeles, CA 90024 (hereinafter, the “Assignee”), on the other hand.

WHEREAS, Assignor is the owner of the mark, TAYLOR GANG® (“Mark”), as set forth in the following registrations (collectively, the “Registrations) (the Mark and Registrations are hereinafter collectively referred to as the “Property”):

TAYLOR GANG® in cl. 25, Registration No. 4,605,980; and  
TAYLOR GANG® in cl. 43, Registration No. 5,129,417

WHEREAS, Assignee wishes to acquire from Assignor all of its right, title and interest in, to and under such Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers, conveys and grants to Assignee, its successors, assigns and legal representatives forever, Assignor’s entire right, title and interest in and to such Property, all of the foregoing throughout the world in perpetuity, together with the goodwill associated therewith and that part of the Assignor’s business connected with the use thereof and symbolized thereby, and any and all of Assignor’s other rights, privileges and priorities provided under state and federal law of the United States, and under the laws of any and all foreign jurisdictions with respect to the Property, including without limitation, Assignor’s common law rights and rights under the laws of unfair competition, and any and all rights of action at law and suits in equity to recover for past infringements of the Property currently known to Assignor as of the date hereof or that may become known after the date of this Agreement

(the "Transferred Rights"), and any and all of Assignor's rights to obtain renewals, reissues, and extensions for such Property upon registration of such Property throughout the world, or other legal protections pertaining to the Transferred Rights;

AND, Assignor hereby covenants that Assignor has the full right to convey the interest assigned by this Agreement, has not conveyed any interest in or right to the Property to any third party; and

AND, Assignor hereby further covenants and agrees that Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to Assignor respecting the Property, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Property in said Assignee, its successors and assigns, and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper trademark and service mark protection for the Property in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by Assignee, its successors and assigns.
