**RESOLVED**, that Article I of the Articles of Incorporation of this corporation shall be amended to read as follows:

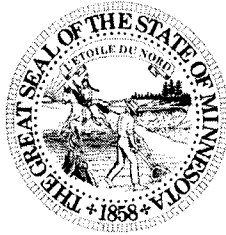
**Article I**
