CONFIRMATORY ASSIGNMENT

Whereas, Karaya (Jersey) Limited, a company registered in Jersey, 1st Floor, Kensington Chambers, 46/50 Kensington Place, P.O. Now, therefore, to whom it may concern, be it known that for the consideration described above Assignor hereby confirms and certifies that it sold, assigned and transferred and does hereby sell, assign and transfer to Assignee the Trademark and the Registration together with the goodwill of the business in connection with which the Trademark is used as of August 18, 2016.
