## **RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of March 7, 2018 (this "Release") is made by Madison Capital Funding LLC, as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of October 19, 2012 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") from Engage2Excel, Inc., formerly TharpeRobbins Company Inc. (the "Grantor") to the Agent.


WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office at reel 4890, frame 0097, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those trademarks set forth on Schedule 1 attached hereto; and

WHEREAS, the Grantor has requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademark Collateral.
