RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS

March 9, 2018

WHEREAS, reference is hereby made to that certain Commercial Security Agreement (the "Agreement"), dated October 14, 2014, executed by Apache Golf, Inc., a California corporation ("Grantor"), in favor of East West Bank, a California corporation ("Lender"), which was filed and recorded with the United States Patent and Trademark Office on November 6, 2014 (Reel: 005396 Frame: 0497-0504), and pursuant to which Grantor assigned and granted to Lender a security interest in and to all of Grantors' right, title and interest in and to certain trademarks, including those trademarks specifically listed on Schedule I attached hereto (the "Marks"); and

WHEREAS, in accordance with that certain Asset Purchase Agreement (the "Purchase Agreement"), dated February 28, 2018, by and between Matrix D, LLC, a Delaware limited liability company ("Purchaser"), and Kenneth A. Krasne (the "Receiver"), the Receiver, in its capacity as court-appointed receiver for Grantor, among others, is selling the Marks, among other assets, to Purchaser; and

WHEREAS, subject to the terms of the Purchase Agreement, Lender wishes to terminate the Agreement and release, retransfer and reassign to Purchaser, as the successor-in-interest of Grantor, without representation or warranty, all of Lender's right, title and interest in and to the Marks and the goodwill associated therewith.

NOW, THEREFORE, subject to Purchaser's fulfillment of its obligations under the Purchase Agreement, effective as of the Closing (as defined in the Purchase Agreement), Lender hereby terminates the Agreement and releases any and all liens and security interests of Lender in and to the Marks, and retransfers and reassigns to Purchaser, as the successor-in-interest of Grantor, without representation or warranty, all right, title and interest of Lender in and to the Marks and the goodwill associated therewith.

IN WITNESS WHEREOF, Lender has executed this Release and Reassignment of Trademarks and Trademark Applications as of the date first above written.
