Whereas, BRANDS desires to assign the entire right, title and interest in and to the Intellectual Property to TOGI, including without limitation the right to sue and collect damages for past, present and future infringements thereof;

Whereas, TOGI hereby agrees to cause BRANDS to have a non-exclusive license with the right to sublicense in and to the Intellectual Property;

Now therefore, for and in consideration of TOGI's agreement to grant to BRANDS a non-exclusive license with the right to sublicense, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BRANDS hereby assigns, transfers, conveys and sets over to TOGI, *nunc pro tunc* as of March 15, 2017, the entire right, title and interest in and to the Intellectual Property, including without limitation the entire right, title and interest in and to the trademark and copyright registrations and applications for registration listed at Schedule A, and along with any and all goodwill symbolized thereby, the same to be held and enjoyed by TOGI, its successors,

assigns and other legal representatives. BRANDS further assigns to TOGI the right to sue and collect damages for past, present and future infringements of the Intellectual Property.
