## TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of May 30, 2017, by Monroe Capital Management Advisors, LLC, as Administrative Agent. WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Trademarks and Trademark Collateral.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
