TERMINATION OF SUPPLEMENTAL GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

Grantee agrees that, upon request of Grantor or any successor-in-interest or assignee thereof, and at Grantor's sole cost and expense, Grantee will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by Grantor, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.
