RELEASE OF COPYRIGHT SECURITY INTEREST

This **RELEASE OF COPYRIGHT SECURITY INTEREST** (this "Release") is dated as of March 15, 2018 by Sun Rowe Finance, LLC, in its capacity as junior lender and subordinated creditor (together with any successors and assigns thereto in such capacity, the "Lender"), in favor of Rowe Fine Furniture, Inc., a Delaware corporation ("Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below) and/or the Note (as defined below).

WHEREAS, pursuant to that certain Senior Subordinated Secured Promissory Note dated as of June 29, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Note") by Grantor, Rowe Furniture Mid-Atlantic, Inc., a Delaware corporation ("Mid-Atlantic"), and Clayton-Marcus Company, Inc., a Delaware Corporation ("Clayton"), collectively with Grantor and Mid-Atlantic, each a "Borrower" and collectively the "Borrowers", in favor of the Lender, the Lender made certain financial accommodations available to Borrowers pursuant to the terms and conditions thereof; and

WHEREAS, Grantor and certain of its affiliates executed and delivered to the Lender that certain Security Agreement dated as of June 29, 2012 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Lender that certain Copyright Security Agreement, dated as of June 29, 2012 (including all schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Copyright Security Agreement");

WHEREAS, the Copyright Security Agreement was recorded with the United States Copyright Office on July 6, 2012 at Volume 3618, Doc. No. 111; and


WHEREAS, the Lender desires to release any and all security interest it has in any of the following (collectively, the "Released Collateral"): (i) Copyright Collateral, (ii) Copyrights set forth on Schedule I hereto, and (iii) any other new copyright registrations or applications referenced in Section 4 of the Copyright Security Agreement.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby (i) terminates the Copyright Security Agreement, (ii) terminates, releases and forever discharges the security interest and any and all other rights granted to it with respect to the Released Collateral, and (iii) transfers and assigns to Grantor any right, title, or interest the Lender may have in, to, or under the Released Collateral. Lender hereby authorizes the Grantor to file this Release with the United States Copyright Office.
