## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), is made and entered into as of February 1, 2018, by and between Super Conventions, Inc. ("Assignor") and Mike Broder Productions LLC ("Assignee"), a Florida limited liability company.

1. Assignor hereby grants, conveys, assigns, transfers, sells, releases, sets over and confirms to Assignee, in perpetuity, all of Assignor's right, title and interest in and to (i) the Trademark, (ii) any and all intellectual property and other proprietary rights in and to such Trademark, including all goodwill connected with the use thereof and symbolized thereby, (iii) any and all legal actions and rights and remedies at law or in equity, including the right to sue for, collect and retain all damages, profits, proceeds, and all other remedies for past infringement, misappropriations, other violations of the Trademark, and (iv) any and all rights corresponding thereto in the United States, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, or other legal representatives.
2. Each party hereto will, at the Assignee's expense, take such further actions and execute promptly such further documents as are necessary to effect the above assignment.
3. This Agreement shall be nunc pro tunc effective as of March 20, 2017.
