Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Marks.

Assignor agrees that at any time and from time to time after the date hereof, at the request of Assignee and without further consideration, Assignor shall execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey and assign to Assignee, and to confirm Assignee's right, title and interest in and to the Marks.

Nothing in this Trademark Assignment, express or implied, is intended or shall be construed to confer upon, or give to, any person, other than the parties to this assignment, any rights, remedies, obligations or liabilities.

This Trademark Assignment shall bind and inure to Assignee and Assignor and their respective successors and assigns.

This Trademark Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same.
