**RELEASE OF SECURITY INTEREST IN  
TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release"), dated as of March 15, 2018, is made by Wells Fargo Bank, National Association, as Administrative Agent (the "Agent"), pursuant to the Credit Agreement dated as of April 26, 2016 (as amended, supplemented, extended, restated, or otherwise modified from time to time, the "Credit Agreement"); and the US Guaranty and Security Agreement dated as of June 30, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

**WITNESSETH**

WHEREAS, AVAD LLC, a Delaware limited liability company (the "Grantor") is a party to the Credit Agreement and the Security Agreement;

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantor executed and delivered to the Agent that certain Trademark Security Agreement, dated as of June 30, 2016 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on June 30, 2016 at Reel/Frame No. 5822/0901, pursuant to which the Grantor granted to the Agent a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreement have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Agent release its security interest in all of its right, title and interest in and to the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby **DISCHARGES, TERMINATES and RELEASES**, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Trademark Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Credit Agreement and the Security Agreement.

Delivery of an executed signature page of this release by electronic transmission shall be as effective as delivery of a manually executed counterpart hereof. The Agent acknowledges that this Release along with any other necessary documentation may be filed with the USPTO or any other governmental office to evidence the discharge, termination and release granted herein. The Agent authorizes the Grantor and its designees to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Agent's security interest in the Collateral.
