**RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY
AGREEMENT**

This **RELEASE OF THE AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT** is dated as of March 15, 2018. Reference is hereby made to the Amended and Restated Trademark Security Agreement (the “Agreement”), dated as of April 1, 2016, by and between, MMM Holdings, Inc., a Puerto Rico corporation n/k/a MMM Holdings, LLC, a Puerto Rico limited liability company (“Pledgor”) and Wilmington Trust, National Association, as administrative agent (as successor to Bank of America, N.A.) (“Administrative Agent”), recorded with the United States Patent and Trademark Office on June 14, 2016, at Reel/Frame 005813/0191. Defined terms used herein shall have the meaning set forth in the Agreement.

WHEREAS, the Pledgor granted to the Administrative Agent for the benefit of the Secured Parties a lien on and a security interest in and to all of its right, title and interest in, to and under the following: (i) the trademarks listed on Schedule A attached hereto (ii) all Goodwill and (iii) all Proceeds of the foregoing (the “Trademark Collateral”);


WHEREAS, the Administrative Agent has agreed to terminate and release its security interests in the Trademark Collateral.
