**TRADEMARK SECURITY AGREEMENT**, dated as of March 16, 2018, by REVOLUCION HOLDING, INC., d/b/a CONDADO TACO, a Delaware corporation (“Holding”), CONDADO TACOS 1 LLC, a Delaware limited liability company (“Condado 1”), CONDADO TACOS 2 LLC, a Delaware limited liability company (“Condado 2”), CONDADO TACOS 3 LLC, a Delaware limited liability company (“Condado 3”), CONDADO TACOS 4 LLC, a Delaware limited liability company (“Condado 4”), CONDADO TACOS 5 LLC, a Delaware limited liability company (“Condado 5”), CONDADO TACOS 6 LLC, a Delaware limited liability company (“Condado 6”), CONDADO TACOS 7 LLC, a Delaware limited liability company (“Condado 7”), CONDADO TACOS 9 LLC (“Condado 8”) CONDADO TACOS 9 LLC, a Delaware limited liability company (“Condado 9” and together with Holding, Condado 1, Condado 2, Condado 3, Condado 4, Condado 5, Condado 6, Condado 7, and Condado 8, each a “Borrower”, and collectively, the “Borrowers”), each of the entities listed on the signature pages hereof as grantors or that becomes a party hereto pursuant to Section 8.8 (Property Acquired After Effective Date; Further Assurances) of the Loan Agreement referred to below (together with the Borrowers, each a “Grantor” and, collectively, the “Grantors”) in favor of The Huntington National Bank (“Lender”).

**WITNESSETH:**

WHEREAS, pursuant to the Loan and Security Agreement, dated as of March 16, 2018 (the “Loan Agreement”) among the Borrowers and Lender, Lender has agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

NOW, THEREFORE, in consideration of the premises and to induce Lender to enter into the Loan Agreement and to induce Lender to continue to make extensions of credit to the Borrowers thereunder, each Grantor hereby agrees with Lender as follows:

**Section 1. Defined Terms**

Unless otherwise defined herein, terms defined in the Loan Agreement and used herein have the meaning given to them in the Loan Agreement.

**Section 2. Grant of Security Interest in Trademark Collateral**

Each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations, hereby collaterally assigns, conveys, mortgages, pledges, hypothecates and transfers to Lender, and grants to Lender a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the “Trademark Collateral”):

- (a) all of its trademarks and trademark licenses to which it is a party, including, without limitation, those referred to on Schedule I hereto;
- (b) all reissues, continuations or extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark license; and

(d) all Proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present, future (i) infringement or dilution of any trademark or trademark licensed under any trademark license or (ii) injury to the goodwill associated with any trademark or any trademark licensed under any trademark license.

**Section 3. Loan Agreement**


