**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement ("Agreement") is made and entered into as of November 1, 2017, by and between Aetna Inc., a corporation organized under the laws of Pennsylvania ("Aetna"), and Aetna Life Insurance Company, a corporation organized under the laws of Connecticut, on the one hand (each individually, an "Assignor", and collectively, "Assignors"), and Hartford Fire Insurance Company, a corporation organized under the laws of Connecticut, on the other hand ("Assignee"). Assignors and Assignee are collectively referred to as the "Parties".

**WHEREAS**, Assignors are the owners of the trademarks and applications and registrations therefor set forth on Schedule A hereto, including all common law rights therein and the goodwill associated therewith (collectively, the "Trademarks"); and

**WHEREAS**, pursuant to that certain Master Transaction Agreement, dated as of October 22, 2017 by and between Aetna and Assignee (the "MTA"), Aetna, on behalf of itself and the other Assignor, agreed to assign, sell, convey and transfer all of each such Assignor's right, title, and interest in and to the Trademarks to Assignee.


**NOW, THEREFORE**, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. **Assignment**. Each Assignor hereby irrevocably sells, conveys, and transfers to Assignee, its successors, and assigns all of such Assignor's right, title, and interest in and to the Trademarks, together with the right to bring an action or proceeding at law or in equity or before any governmental authority for any past, present, or future infringement or violation of any of the Trademarks, and to collect all damages, awards, settlements, and proceeds relating to the Trademarks. Each Assignor consents to recordation of this Agreement by Assignee with the United States Patent and Trademark Office or successor offices.
2. **Governing Law**. This Agreement shall be construed in accordance with and governed by the laws of New York.
3. **No Conflict**. Nothing in this Agreement shall alter any liability or obligation of the Parties arising under the MTA. In the event of a conflict between the terms and conditions of this Agreement and the terms and conditions of the MTA, the terms and conditions of the MTA shall govern.
4. **No Modifications**. This Agreement may not be supplemented, altered, or modified in any manner except by a writing signed by all Parties hereto.
5. **Successors and Assigns**. This Agreement shall bind and shall inure to the benefit of the respective Parties and their successors, assigns, and transferees.
6. **Counterparts**. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original but both of which together will constitute one and the same instrument.




