**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of March 16, 2018, by **DEUTSCHE BANK TRUST COMPANY AMERICAS**, a New York trust company (the “Administrative Agent”) in favor of **CYANCO HOLDING CORP.**, a Delaware corporation with an address at 9450 Double R Blvd., Suite 2, Reno, Nevada 89521 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated May 1, 2013 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on May 1, 2013 at the United States Patent and Trademark Office at Reel 5019, Frame 0313.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.


WHEREAS, the Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all of such Grantor’s right, title, and interest in, to and under the Trademarks, including those listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the Lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademarks of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
