**CONFIRMATION OF ASSIGNMENT OF  
TRADEMARK SECURITY AGREEMENT**

This CONFIRMATION OF ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT (the "Confirmation Agreement") dated as of March 9, 2018, is made by GOLDMAN SACHS MORTGAGE COMPANY, CITIGROUP GLOBAL MARKETS REALTY CORP. and BANK OF AMERICA, N.A., collectively, as assignor (the "Assignor"), and WILMINGTON TRUST, NATIONAL ASSOCIATION, SOLELY IN ITS CAPACITY AS TRUSTEE FOR THE BENEFIT OF THE HOLDERS OF THE CHICAGO SKYSCRAPER TRUST 2017-SKY, COMMERCIAL MORTGAGE PASS-THROUGH CERTIFICATES, SERIES 2017-SKY, as assignee (the "Assignee"). Capitalized terms used but not defined herein shall have the meanings given to them in the Loan Agreement, the Mortgage, or the Trademark Security Agreement (each as defined below) unless otherwise specified herein.

WITNESSETH:

WHEREAS, BRE 312 OWNER LLC, a Delaware limited liability company (the "Pledgor"), Assignor and the other parties thereto entered into that certain Loan Agreement, dated as of February 10, 2017 (as amended from time to time, the "Loan Agreement");

WHEREAS, in connection with the Loan Agreement, Pledgor is party to that certain Fee and Leasehold Mortgage, Assignment of Rents and Leases, Collateral Assignment of Property Agreements, Security Agreements and Fixture filing dated February 10, 2017 and recorded February 10, 2017 as Document No. 1704119092 in the office of the County of Cook, State of Illinois ("Official Records") (the "Original Mortgage");

WHEREAS, pursuant to the Original Mortgage, (i) Pledgor has granted a security interest (the "Security Interest") to Assignor, in certain collateral, including the Trademark Collateral (as herein defined); and (ii) Assignor and Pledgor executed that certain Trademark Security Agreement dated as of February 10, 2017 (the "Trademark Security Agreement") to record such Security Interest at the U.S. Patent and Trademark Office, and such Security Interest was recorded at the USPTO on March 6, 2017 at Reel 6002 and Frame 0005;

WHEREAS, the Original Mortgage was assigned by Assignor to Assignee pursuant to that certain Assignment of Fee and Leasehold Mortgage, Assignment of Rents and Leases, Collateral Assignment of Property Agreements, Security Agreement and Fixture Filing recorded April 28, 2017 as document 1711857116 in the Official Records (the "Assignment of Mortgage", the Assignment of Mortgage, together with the Original Mortgage, the "Mortgage");

WHEREAS, Assignor and Assignee wish to confirm and record that Assignor's interest in the Trademark Security Agreement has been assigned to Assignee pursuant to the Assignment of Mortgage;

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the parties hereto state as follows:

1. Definitions. The term "Trademark Collateral" as used herein, shall mean all of Pledgor's worldwide right, title and interest to the Trademarks set forth on Schedule A attached hereto, together with the right to sue for past, present, and future infringements, dilutions or violations of such Trademarks and all goodwill associated with or symbolized by such Trademarks. The term "Trademarks" shall have the meaning provided by reference in the Original Mortgage. Unless otherwise defined herein, terms defined in this Confirmation Agreement and used herein have the meaning given to them in the Trademark Security Agreement.

2. Assignment. Assignor and Assignee hereby confirm that, pursuant to the Assignment of Mortgage, as of April 28, 2017, Assignor assigned all of Assignor's Security Interest in the Trademark Collateral, and all of Assignor's rights in the Trademark Security Agreement to Assignee. The Trademark Security Agreement shall remain in full force and effect between Pledgor and Assignee in accordance with its terms.

3. Further Assurances. Assignor hereby agrees to take all further actions and execute and deliver all further documents reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Confirmation Agreement. The Assignor hereby authorizes and requests that the Commissioner for Trademarks of the USPTO record this Confirmation Agreement.

4. Counterparts. This Confirmation Agreement may be executed by the parties in counterparts (including by facsimile or PDF signatures).
