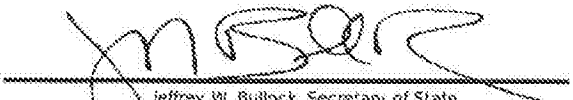

The undersigned Secretary of Mediaspectrum, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), does hereby certify as follows:

FIRST: That the original Certificate of Incorporation of the Corporation was filed in the Office of the Secretary of State of the State of Delaware on November 26, 2001.

SECOND: That the Certificate of Incorporation of the Corporation, Article FIRST, is hereby amended by deleting such Article in its entirety and substituting therefore the following:
