**TRADEMARK ASSIGNMENT AGREEMENT**

This TRADEMARK ASSIGNMENT (“Assignment”) is entered into and effective as of January 31, 2018 (“Effective Date”), by and between ZGS Communications, Inc., a Delaware corporation (“Assignor”), and Telemundo Network Group LLC, a Delaware limited liability company (“Assignee”).

WITNESSETH:

WHEREAS, Assignor, certain affiliates of Assignee, and certain other parties have entered into that certain Asset Purchase Agreement, dated as of December 1, 2017 (the “Agreement”), providing for, among other things, the assignment, transfer and conveyance by Assignor to NBCUniversal Media, LLC (“NBCU”) of all rights, title and interest in and to certain trademarks that are the subject of one or more registrations with the United States Patent and Trademark Office, namely those registrations filed with the United States Patent and Trademark Office as set forth on Exhibit A attached hereto (the “Trademarks”);

WHEREAS, NBCU has nominated Assignee, its wholly-owned subsidiary, to accept all rights, title and interest to the Trademarks on its behalf; and

WHEREAS, based on the foregoing, the parties wish to effectuate transfer of the Trademarks in order to reflect Assignee’s ownership of the Trademarks, and give notice of transfer to the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby sells, conveys, transfers, assigns and delivers to Assignee any and all right, title and interest that Assignor has or may have in and to the Trademarks, the registration therefor and the goodwill associated with and symbolized by the Trademarks, and all claims for damages by reason of past infringement of the Trademarks with the right to sue for and collect damages (collectively, the “Trademark Rights”).

2. Assignor agrees to execute and deliver at a future date any and all further acts, conveyances, transfers, assignments, instruments and assurances, without compensation (but at Assignee’s expense), as Assignee reasonably determines are required to perfect Assignee’s ownership of or title to the Trademarks and any registrations or applications therefor or to evidence the full and effective implementation and consummation of the assignment of such Trademarks and any registrations therefor.

3. This Assignment may be executed in one or more counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same Assignment. A facsimile or PDF copy of an original signature shall be deemed an original signature.

4. This Assignment is intended only to effect the assignment, transfer and conveyance of the Trademark Rights. Accordingly, nothing contained herein shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect any of the terms and conditions of the Agreement.
