RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release"), dated and effective as of March 20, 2018 (the "Effective Date"), is made by PNC BANK, NATIONAL ASSOCIATION, a United States National Association ("PNC") in favor of Key Technology, Inc., an Oregon corporation ("Key").

RECITALS

WHEREAS, pursuant to that certain Revolving Credit, Term Loan and Security Agreement, dated as of July 20, 2015, by and between Key and PNC (as amended, restated, supplemented or otherwise modified from time to time, including all exhibits and schedules thereto, the "Credit Agreement"), Key granted to PNC a security interest in and to certain Trademark Collateral (as defined below);

WHEREAS, pursuant to the Credit Agreement, Key executed and delivered a Trademark Security Agreement, dated July 20, 2015 (the "Trademark Security Agreement") for recordal with the United States Patent and Trademark Office (the "USPTO"), evidencing PNC's security interest in the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the USPTO on July 21, 2015, at Reel/Frame 5582/0508; and

WHEREAS, Key has fully satisfied all of its obligations under the Credit Agreement, and the indebtedness described in and the obligations under the Credit Agreement and all security interests in the Trademark Collateral (as defined below) are fully discharged and released, and the Credit Agreement and the Trademark Security Agreement are canceled and terminated.

TERMS AND CONDITIONS

NOW, THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, PNC hereby agrees as follows:


1. Termination and Release. PNC hereby: (a) terminates and cancels the Credit Agreement, the Trademark Security Agreement and any other agreement under which Key has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien or security interest in, to and under all of Key's trademarks, trademark applications, service marks, trade names and associated good will (collectively, "Trademarks"), and licenses for any of the foregoing ("Licenses"), including those referred to on Exhibit A hereto, and all proceeds of the foregoing, including any claim by Key against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License (collectively, the "Trademark Collateral"); (b) irrevocably releases, cancels and discharges the pledge and lien on and security interest in and to all of its (and its predecessors', successors', assigns' or transferees', as applicable) present and future right, title and interest in, to and under the Trademark Collateral; and (c) authorizes the recordation of this Release against the Trademark Collateral with the USPTO and any other authority or office as may be necessary to effectuate this Release.

2. Further Assurances. PNC agrees to cooperate with Key and to execute, acknowledge and deliver such further releases, termination statements, assignments and other assurances pursuant to this Release, as may be reasonably requested by Key in order to effectuate the complete release of PNC's security interest in the Trademark Collateral.

3. Successors and Assigns. This Release shall be binding upon PNC's successors, assigns, transferees and other legal representatives, and is made in favor of and for the benefit of Key and its respective successors and assigns.
