**PLAN OF CONVERSION

*Pursuant to Section 47-1A-951 of the South Dakota Business Corporation Act
and Section 18-214 of the Delaware Limited Liability Company Act*

1. The name of the converting organization is Diamond Mowers, Inc. (the "Converting Entity").

5. CERTIFICATE OF FORMATION

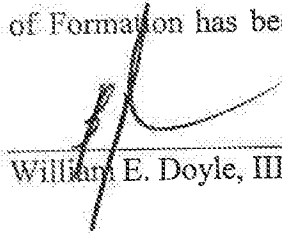
The undersigned, being a natural person 18 years of age or older, in order to form a limited liability company under the Delaware Limited Liability Company Act, Delaware Code, Title 6, §§ 18-101-1109, as the same may be amended, supplemented or restated from time to time (the "*Act*"), hereby adopts the following Certificate of Formation in accordance with Section 18-201 of the Act:

1. Name. The name of the limited liability company is Diamond Mowers, LLC (the "*Company*").
