**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest ("Release") is given on this 21st day of March 2018, by JPMORGAN CHASE BANK, N.A. (the "Grantee"), to ABACUS AMERICA, INC. (the "Grantor"), as follows:

WHEREAS, the Grantor and the Grantee are parties to a Pledge and Security Agreement dated March 12, 2010 (the "Security Agreement") pursuant to which the Grantor entered into a Confirmatory Grant of Security Interest in United States Trademarks dated as of March 12, 2010 (the "Confirmatory Grant") in favor of the Grantee;

WHEREAS, pursuant to said Security Agreement and Confirmatory Grant, the Grantor granted to the Grantee, among other collateral as set forth therein, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under its United States trademarks, including but not limited to the trademarks listed on the attached Schedule A, together with all products and proceeds of such trademarks and all causes of action arising prior to or after the date thereof for infringement of such trademarks (the "Trademarks");

WHEREAS, the Confirmatory Grant was recorded in the United States Patent & Trademark Office on March 15, 2010 at reel/frame 004167/0432;

WHEREAS, the Grantor has satisfied its obligations under the Security Agreement and the Confirmatory Grant (including all conditions for release), and the Grantee wishes to release its security interest in the Trademarks, including those listed on Schedule A and retransfer and reassign to the Grantor without recourse all of the Grantee's right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby (i) terminates the Confirmatory Grant and releases any security interest, right or other interest it may have in the Trademarks, including those listed on Schedule A, and hereby reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantor, together with the goodwill of the business symbolized thereby and (ii) agrees to execute, acknowledge, procure and deliver to Grantor, at Grantor's expense, any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Grantor's (or their assignees') right, title and interest in and to the Trademarks.
