## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of March 1, 2018, is made by **FIFTH THIRD BANK**, an Ohio banking corporation, as Agent for the benefit of the Secured Creditors ("Agent"), and is as follows:

WHEREAS, LASERSHIP, INC., a Delaware corporation ("LaserShip"), PRESTIGE DELIVERY SYSTEMS, LLC, a Delaware limited liability company ("Prestige"; each of LaserShip and Prestige, a "Debtor"), and Agent are parties to that certain (i) Trademark Security Agreement dated as of October 10, 2014, which was recorded with The United States Patent and Trademark Office on October 26, 2014 in its records at Reel 5387, Frame 0690 (the "Trademark Security Agreement") and (ii) First Amendment to Trademark Security Agreement dated as of November 22, 2017, which was recorded with The United States Patent and Trademark Office on November 28, 2017 at Reel 6214, Frame 0191 (the "First Amendment" and together with the Trademark Security Agreement, the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Agent a security interest in all of each Debtor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including, without limitation: (a) all of each Debtor's right, title and interest in and to all of its now owned or in the future owned or existing trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications (except as provided in the Agreement), including each mark, registration, and application listed on Schedule I attached hereto and made a part hereof (the property in this item (a) being, each, a "Trademark", and collectively, the "Trademarks"); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Trademarks, including damages and payments for past or future infringements of any and all of the Trademarks; (d) all rights to sue for past, present and future infringements of any and all of the Trademarks; (e) all of each Debtor's rights corresponding to each of the Trademarks throughout the world; (f) the goodwill of each Debtor's business connected with the use of, and symbolized by, any of the foregoing; (g) all rights of each Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trademark or service mark registrations, trade names, and trademark and service mark applications, including the licenses listed on Schedule I and the Trademark Licenses; and (h) all books, records, cash and non-cash proceeds of any and all of the foregoing; and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral.


