1. Assignor owns all right, title, and interest to United States Trademark Registration No. 5368035 for the mark BUFFALO BANDITS and Serial No. 87279917




for the mark ("the Trademarks"). Assignor wishes to assign all right, title, and interest to the Trademarks to Assignee.
