CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment agreement ("Assignment") is entered into as of February 27, 2018, by and between Payment Alliance International, Inc., a Delaware corporation ("Assignor") and Clearent Merchant Services, Inc. 1. Assignor hereby confirms that, as of the Effective Date, it sold, assigned and transferred to PAI Merchant Services, Inc., the benefit of which shall inure to its successors and assigns, all right, title, and interest in, to and under the trademarks set forth on Exhibit A, including any and all goodwill associated therewith, all applications and registrations therefor, all common law rights therein, any and all trademark and/or service mark rights related thereto; and in and to any and all causes of action (either in law or in equity), as well as the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of these marks (the "Transferred Marks").

2. Assignor hereby authorizes and requests the U.S. Patent and Trademark Office to record PAI Merchant Services, Inc. as the owner of the Transferred Marks.

3. In the event of any conflict or inconsistency between the terms of this Assignment and the terms of the Contribution Agreement, the terms of the Contribution Agreement will prevail. Nothing contained herein shall be deemed to alter, modify, expand or diminish the terms of the Contribution Agreement.
