**RELEASE OF TRADEMARK SECURITY INTEREST**

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of March 22, 2018 (this "Release"), is made by WhiteHorse Finance Inc., as administrative agent for the Lender Group (in such capacity, "Agent"), in favor of Project Time & Cost, LLC, a Georgia limited liability company (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of October 9, 2015 and recorded with the United States Patent and Trademark Office (the "USPTO") on October 9, 2015 at Reel 5642 Frame 0048 (the "Trademark Security Agreement"; capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement), made by the Grantor in favor of Agent and (ii) the Security Agreement, the Grantor granted to Agent a continuing first priority security interest in all of the Grantor's right, title and interest in, to and under all of its Trademark Collateral, including all trademarks and tradenames referred to on Schedule I hereto; and

**WHEREAS**, pursuant to the terms of that certain payoff letter, dated as of the date hereof, by and among Agent, the Grantor and Project Time & Cost Holdings, Inc., Agent has consented to the release of its security interest in the Trademark Collateral granted pursuant to the Security Agreement and the Trademark Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) releases, assigns and conveys, without recourse or warranty to the Grantor, its security interest in the Trademark Collateral granted pursuant to the Security Agreement and the Trademark Security Agreement, (ii) terminates the Trademark Security Agreement (other than any provisions therein that specifically survive termination) and (iii) authorizes the Grantor (or its designee) to file this Release with the USPTO.
