
TURTLE BEACH CORPORATION, a Nevada corporation, whose address is 11011 Via Frontera, Suite A, San Diego, CA 92127 (“Parent”) and **VOYETRA TURTLE BEACH, INC.**, a Delaware corporation, whose address is 100 Summit Lake Drive, Suite 100, Valhalla, New York 10594 (“Voyetra”; and together with Parent, individually a “Debtor” and individually and collectively, jointly and severally, “Debtors”) hereby acknowledges that it has granted to **BANK OF AMERICA, N.A.**, as Agent whose address is 333 South Hope Street, Suite 1300, Los Angeles, California 90071 (the “Secured Party”), a security interest in and to all of the Debtor’s right, title and interest in and to: (a) the trademarks and trademark registrations and applications therefor which are identified on Exhibit A attached hereto and herein incorporated by this reference owned by Debtor (the “Trademarks”), together with the goodwill and assets of the business; (b) the patents and patent applications which are identified on Exhibit B attached hereto and herein incorporated by this reference owned by Debtor (the “Patents”); and (c) the copyright registrations which are identified on Exhibit C attached hereto and herein incorporated by this reference owned by Debtor (the “Copyrights”), to which such Trademarks, Patents and Copyrights are appurtenant and all actions for infringement concerning the foregoing.

The terms and conditions of the aforementioned security interest are contained in that certain Amended and Restated Loan, Guaranty and Security Agreement dated as of March 5, 2018 (as amended, restated, or otherwise modified from time to time, the “Agreement”), by and among Debtors, **TURTLE BEACH EUROPE LIMITED**, a company limited by shares and incorporated in England and Wales with company number 03819186 (“Turtle Beach,” also referred to hereinafter as “UK Borrower”; and together with Debtors, individually “Borrower” and individually and collectively, “Borrowers”), **PSC LICENSING CORP.**, a California corporation (“PSC”), **VTB HOLDINGS, INC.**, a Delaware corporation (“VTB”; and together with PSC, individually “US Guarantor,” and individually and collectively, jointly and severally, “US Guarantors”; and together with Debtors, individually “UK Guarantor” and individually and collectively, jointly and severally, “UK Guarantors”; UK Guarantors and US Guarantors, individually a “Guarantor,” and individually and collectively, “Guarantors”); the financial institutions party to the Agreement from time to time as lenders (collectively, “Lenders”), and Secured Party as security for the Obligations as set forth in the Agreement and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Secured Party may have in any other collateral described in the Agreement or otherwise.
