Assignor shall, at Assignee's request, execute and deliver to Assignee such additional instruments of conveyance, assignment and transfer as may be prepared by Assignee, and take such other action as Assignee may reasonably require, in order to vest in Assignee all right, title and interest of Assignor in and to the Marks, as contemplated herein. Assignor and Assignee hereby authorize and request the U.S. Commissioner of Patents and Trademarks to


record ownership of the Marks in Assignee, its successors or assigns, in accordance with the terms of this Assignment.


