The Assignee wishes to acquire the Assignor's rights in the trademark listed in this agreement.

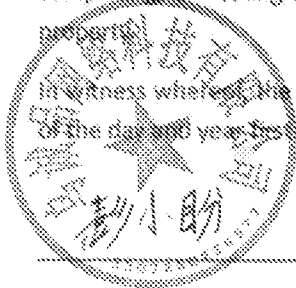
The Assignor agrees to transfer the trademark to the Assignee for free.
