

SuperMedia LLC, a limited liability company duly organized and existing under and by virtue of the laws of the State of Delaware, desiring to merge SuperMedia BRE LLC, a limited liability company duly organized and existing under and by virtue of the laws of the State of Delaware, with and into itself, pursuant to the provisions of Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "Delaware Code"), DOES HEREBY CERTIFY as follows:

FIRST: The name and state of formation of each constituent entity of the merger (the "Merger") are as follows: (i) SuperMedia LLC, a Delaware limited liability company (the "Company") and (ii) SuperMedia BRE LLC, a Delaware limited liability company ("SuperMedia BRE").
