Pursuant to Section 251(a) of the General Corporation Law of the State of Delaware (the “DGCL”), Enviance, Inc., a Delaware corporation, does hereby certify the following information in connection with the merger of Actio Software Corporation, a Delaware corporation, with and into Enviance, Inc. (the “Merger”):

FIRST: The name and state of incorporation of each of the constituent corporations in the Merger (the “Constituent Corporations”) are as follows:

SECOND: The Agreement and Plan of Merger, dated as of December 15, 2017, by and between Enviance, Inc. and Actio Software Corporation (as amended, modified, and supplemented from time to time, the “Merger Agreement”) has been approved, adopted, executed and acknowledged by each of the Constituent Corporations pursuant to and in accordance with the requirements of Section 251(a) of the DGCL (and, with respect to Actio Software Corporation, by the written consent of its sole stockholder in accordance with Section 228 of the DGCL).

THIRD: The name of the surviving corporation in the Merger (the “Surviving Corporation”) shall be “Enviance, Inc.”

FOURTH: The certificate of incorporation of Enviance, Inc. as in effect immediately prior to the Merger shall be the certificate of incorporation of the Surviving Corporation until thereafter amended as provided therein or by applicable law.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either Constituent Corporation.
