TRADEMARK ASSIGNMENT

WHEREAS, Assignor owns, all right, title, and interest in certain U.S. Trademark Registrations as set forth on Schedule A (collectively, the "**Trademarks**") and all of the goodwill of the business symbolized by the Trademarks or a portion of the business to which the Trademarks pertain;

WHEREAS, Assignee desires to own Assignor's entire right, title, and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks or a portion of the business to which the Trademarks pertain; and

WHEREAS, Assignor has agreed to assign the Trademarks to Assignee.

NOW THEREFORE, be it known that, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor, as of the date hereof, hereby irrevocably sells, assigns, transfers, and sets over to Assignee, its lawful successors and assigns, Assignor's entire right, title, and interest in and to the Trademarks and all registrations, applications, and renewals thereof, together with the goodwill of the business symbolized by the Trademarks or a portion of the business to which the Trademarks pertain; and Assignee hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office to issue all Registrations for the Trademarks to Assignee, its successors and assigns, in accordance with the terms of this Agreement;

AND, ASSIGNOR HEREBY further covenants that Assignor has the full right to convey the interest assigned by this Agreement, Assignor will take all action and execute all documents necessary to perfect the interest assigned hereby, and Assignor has not executed and will not execute any agreement in conflict with this Agreement;

AND, ASSIGNOR HEREBY further covenants and agrees that Assignor, through its officers and employees, will, without further consideration: (i) communicate with Assignee, its successors and assigns any facts known to Assignor and its officers and employees regarding the Trademarks; (ii) and testify in any legal proceeding concerning the Trademarks; (iii) execute and deliver all lawful papers that may be necessary or desirable to perfect the Trademarks to and in said Assignee, its successors and assigns; (iv) make all rightful oaths; and (v) generally do everything reasonably possible to aid Assignee, its successors and assigns with obtaining and enforcing trademark protection for the Trademarks in the United States it being understood that any expense incident to the provision of such aid, including providing testimony in any legal

proceeding or the execution of such papers, shall be borne by Assignee, its successors and assigns;


