RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of February 26, 2018, by and between CRESCENT DIRECT LENDING, LLC, as administrative agent (“Agent”) and ACTION FABRICATORS, INC., a Michigan corporation (“Grantor”). Reference is hereby made to that certain Trademark Security Agreement between the Grantor and the Agent dated August 14, 2015, recorded in the United States Patent and Trademark Office (“USPTO”) on August 14 5, 2015 at Reel/Frame 5599/0726 (the “IP Security Agreement”). Terms used but not defined in this Release shall have the meanings given thereto in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Agent was granted a security interest in and to certain collateral, including the Trademarks listed on Schedule 1 (the “Trademark Collateral”);

WHEREAS, the Grantor has requested that the Agent terminate and release its security interests in and to the Trademark Collateral and execute and deliver evidence of such termination and release for filing in the USPTO; and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Trademark Collateral. Grantor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.


