Exhibit 2 – Trademark Transfer

This Trademark Transfer is effective as of December 27, 2017 (the “Effective Date”) by and between **ALTISOURCE SOLUTIONS S.À R.L.** (“Transferor”) and **ALTISOURCE HOLDINGS S.À R.L.** (to be substantially simultaneously renamed Altisource S.à r.l.) (“Transferee”).

WHEREAS, Transferor and Transferee intend to enter into a merger by absorption with Transferee surviving the merger (the “Merger”) and, simultaneously with such Merger, Transferee’s name will change from Altisource Holdings S.à r.l. to Altisource S.à r.l., and believe that through such Merger, the entire right, title, and interest in the trademarks held by Transferor immediately prior to such Merger – including without limitation those trademarks listed on Exhibit 2A (the “In Use Trademarks”) and Exhibit 2B (the “Intent to Use Trademarks”) and the goodwill associated with all of the foregoing – shall immediately be held by Transferee; and

WHEREAS, Transferor and Transferee wish to remove any doubt as to the owner of the In Use Trademarks and the Intent to Use Trademarks (collectively, the “Trademarks”) and wish to expressly document the transfer of the Trademarks to Transferee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


Effective upon the Merger, Transferor:

- transfers all of the worldwide right, title and interest in and to the Trademarks, together with the goodwill of the business in connection with which the Trademarks are used, and all registrations, renewals, and extensions of the foregoing, now or hereafter in effect, for Transferee’s own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Transferor if this Trademark Transfer had not been made, together with all income, royalties, damages, or payments due or payable as of the Effective Date or thereafter related to any of the foregoing, including, without limitation, all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Trademarks, with the right to sue for and collect the same for Transferee’s own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives. The foregoing transfer shall include, at least with respect to the Intent to Use Trademarks, Transferor hereby transferring to Transferee the Intent to Use Trademarks, together with the goodwill of the business symbolized by the trademark. Each of the Intent to Use Trademarks is being transferred as part of the entire business or portion thereof to which the Intent to Use Trademark pertains, as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060; and
- authorizes and requests the United States Commissioner of Patents and Trademarks, the European Union Intellectual Property Office, the Benelux Office for Intellectual Property and any other similar government authority to record Transferee as owner of the Trademarks (it being understood that the Transferee has a power of attorney to make the necessary recordals in this respect) and issue any and all registrations issued thereon to Transferee, as transferee of the entire right, title, and interest in, to, and under the same, for the sole use and enjoyment of Transferee and its successors, assigns, or other legal representatives.

IN WITNESS WHEREOF, Transferor and Transferee have caused this Trademark Transfer to be duly executed.


