**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of March 27, 2018 by Monroe Capital Management Advisors, LLC, as Administrative Agent (“**Administrative Agent**”).

WITNESSETH:

WHEREAS, Administrative Agent and Output Services Group, Inc., a New Jersey corporation (“**Grantor**”), were parties to that certain Trademark Security Agreement dated as of October 12, 2017 (the “**Security Agreement**”), pursuant to which Grantor granted a security interest to Administrative Agent in certain trademarks (the “**Trademarks**”) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Administrative Agent, including the Trademarks set forth on Schedule I hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 16, 2018, at Reel 6250, Frame 0078; and

WHEREAS, Grantor has requested that Administrative Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Collateral**”):

(a) each U.S. Trademark application and registration, including, without limitation, each Trademark and Trademark application referred to on Schedule I, together with any renewals or divisionals thereof and all goodwill associated therewith (though excluding any “intent to use” Trademark application for which a statement of use or amendment to allege use has not been filed and accepted with the United States Patent and Trademark Office); and;

(b) all product and Proceeds of the foregoing, including, without limitation, any royalties or any claim by Grantor against third parties for past, present or future infringement of any Trademark, including, without limitation, any Trademark referred to in Schedule I and any Trademark issued pursuant to a Trademark application referred to in Schedule I.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent’s right, title and interest in and to the Trademarks.
