RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to (i) that certain Trademark Security Agreement dated as of February 18, 2015 (“2015 Trademark Security Agreement”) made by LogMeIn, Inc. (“LMI”) in favor of JPMorgan Chase Bank, N.A. (“Administrative Agent”) in its capacity as administrative agent for the lenders party to the Credit Agreement and the Pledge and Security Agreement referred to in the 2015 Trademark Security Agreement and (ii) that certain Trademark Security Agreement dated as of February 1, 2017 (“2017 Trademark Security Agreement”) made by LMI, Marvasol Inc., and GetGo, Inc. in favor of Administrative Agent in its capacity as administrative agent for the lenders party to the Amended and Restated Credit Agreement and the Amended and Restated Pledge and Security Agreement referred to in the 2017 Trademark Security Agreement, Administrative Agent is the holder of security interests in certain Trademark Collateral (such term, as used herein, has the meaning given to such term in the 2015 Trademark Security Agreement and in the 2017 Trademark Security Agreement);

WHEREAS, the 2015 Trademark Security Agreement was recorded on May 13, 2015 at Reel 005514, Frame 0925 and the 2017 Trademark Security Agreement was recorded on February 7, 2017 at Reel 006003, Frame 0779 both with the Assignment Recordation Branch of the U.S. Patent and Trademark Office; and

WHEREAS, in connection with LMI’s sale of certain assets, the Administrative Agent has agreed to release its security interest in certain Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby terminates, discharges, and releases any and all security interests it has against the Trademark Collateral related to the trademark listed on Schedule A.
